<u>New Business</u>

Board / committee discussions:

- 1. Fiscal Year End Audit Update
 - The year-end audit update is not yet available from the auditors. A draft report of the audit should be available in the next week or two.
 - The presentation of the audit at the business and work session by Nisivoccia was discussed.
- 2. After School Busing

- The collection of data and public interest in having late bus runs was discussed. With favorable data bus runs could be reduced from fifteen to eight runs and provides drivers a full work load. There are a lower number of students because band is no longer after school.
- 3. YMCA Request for Busing
 - The YMCA proposed students twelve years and older a one month free membership, fifty percent off the first week of a camp if at least two weeks of camp are purchased. A rate of \$1.75 per mile was agreed upon as the rate for letting YMCA use of Randolph buses.
- 4. Update on ROD projects
 - The update on the ROD projects included final inspection on the Shongum roof. Walk pads need to be installed on middle school roof and the blueprints are finished for the maintenance building.
- 5. 2015 2016 Preliminary Budget Discussion
 - Preliminary budget discussion included tax assessments, long range facilities plan, needs of Principals and the impact of taxes on real estate prices. The topic of locking for a new insurance broker was proposed. One year of utility bils more sent to Donnelly for the analysis of LED lighting cost savings
- 6. Review Transfers / POs and Motions
 - The comprehensive maintenance plan (M-1) was brought up in discussion as it needs to be approved every October.
