

## **Education Motions – June 15, 2010 – Version 2**

1. **MOTION** to approve Randolph Township Schools participation in the New Jersey Interscholastic Athletic Association.

**BE IT RESOLVED**, the Randolph Township Board of Education approve enrollment of Randolph High School as a member of the New Jersey Interscholastic Athletic Association to participate in the approved interschool athletic program sponsored by the NJSIAA for the 2010-2011 school year as summarized in **Education Exhibit #1**, attached hereto and made a part of the minutes.

**BE IT FURTHER RESOLVED**, the Randolph Township Board of Education approve the NJSIAA six-day practice requirement for inclusion of Sunday practices for the 2010-2011 school year. Fall Sports practices to begin on August 1, 2010 to include no more than three (3) hours of practice time (in line with the Acclimatization Period from NJSIAA Pre-Season practice Guidelines for Fall Sports 2010-2011). 2. **MOTION** to approve the Randolph Township Schools District Professional Development Plan for the 2010-2011 school year as accepted by the Morris County Professional Development Board.

4. **MOTION** to approve the placement of Randolph Student **SE10-67, Grade 10** in the Special Education program at Shepard High School effective June 1, 2010 and, **BE IT FURTHER MOVED**, that a contract be entered into with Shepard High School at the tuition rate of \$3,485.16 pro rated.
