- **MOTION** to tentatively approve new courses for the 2010-2011 school year based on the following prioritized list and budget restrictions. The courses will be listed in the Randolph Middle School and Randolph High School selection sheets for 2010-2011 and will denote "Pending Board Approval".
 - A. Courses that require no additional materials cost and no additional staff:
 - High School Business Principles (Honors)
 - Middle School Grade 8 cycle courses Computerized Photographic Concepts, Digital Storytelling, OOPS! Computer Simulation Programming
 - B. Randolph High School: Finance Semester Course: This course will require extra staffing at a cost of \$30,000 \$65,000 depending on whether it will be a part-time or full-time offering and text and materials cost of \$3,000. It is mandated by the state for the incoming freshman class as necessary for high school graduation. Discussion was held on whether we need a part-time or full-time position currently depending on registration. Jeanne Stifelman will look into a private grant possibility to fund the instruction of finance.
 - C. Randolph High School: Contemporary Issues On-line This course requires no extra staffing and \$1,000 in text and supplies. It is our first on-line course for high school students, set up to succeed by experienced staff.
 - D & E. <u>Randolph Middle School</u>: Technology in Action Intro to Technology grade 6, The Way Things Work grade 7 Exploring Technology grade 8. These cycles require no extra staff, and a text-supply cost of \$38,000. This is the intended second year of a technology improvement plan begun and funded last year in the Middle School. The cost of these cycles can be met with a part-time finance teacher. Dr. Kane will also look into lease-purchase agreements.

Randolph High School: AP Psychology - This course requires no extra staff and a materials fee of \$4,300. It is the course most requested by

students in a past survey and was tabled last year due to lack of funding, making it a Goal 1 priority. We have highly qualified staff on hand to instruct. The course can possibly be worked in with a part-time finance class and/or some modifications in the Middle School tech cycles.
