<b>GENERAL DESCRIPTION:</b>			
<p>The Athletic Director is responsible for the administration and supervision of the interscholastic athletic programs. The Athletic Director shall be directly responsible to the High School Principal for the performance of his/her duties.</p>			
<b>RESPONSIBILITIES MAY INCLUDE, BUT ARE NOT LIMITED TO:</b>			
<u>Administrative</u> <ol style="list-style-type: none"> <li>1. Organizes and administers the district's program of extracurricular athletics and assumes responsibility for the scheduling of all interscholastic athletic events.</li> <li>2. Develops and implements appropriate rules and regulations governing the conduct of athletic activities and ensures compliance with the rules promulgated by the NJSIAA.</li> <li>3. Verifies each athlete's eligibility according to established physical and academic requirements of eligibility for participation in each sport and obtains written parent permission for students to participate.</li> <li>4. Prepares the annual athletic budget, specifying the projected needs for each sport, with input from the head coaches and the equipment manager.</li> <li>5. Submits the annual budgetary proposal to the principal, and make such changes in that proposal as may be necessary due to financial constraints and/or changing needs of the program.</li> <li>6. Arranges all physical examinations for students participating in sports and for the completion of required permission slips prior to start of the season.</li> <li>7. Maintains records of athletic contests and award winners and plans and supervises an annual recognition program for athletes.</li> <li>8. Develops and oversees an equitable system of determining the distribution of letters and awards to student athletes and insures that students are aware of the system for winning a letter or award.</li> <li>9. Represents the school in any athletic conference meetings, special N.J.S.I.A.A. meetings, and other professional gatherings in order to be better informed regarding interscholastic sports programs.</li> <li>10. Serves as the high school's official administrative liaison with all of the booster and support groups associated with the various high school teams.</li> <li>11. Implements the rules of Title IX of the Educational Amendments of 1972 and title VI of the New Jersey Administrative Code which provide for equal opportunity for members of both sexes in teams, equipment, facilities, supplies, travel, compensation of coaches, scheduling and the selection and payment of officials.</li> </ol>			

Operations

1. Assumes responsibility for the proper supervision of home games and the availability of game officials, athletic trainers and security personnel.
2. Attends all home varsity games, meets, and contests as his/her schedule may permit and designates a representative to act in his/her stead when unable to attend.
3. Assumes responsibility for compliance with board-adopted emergency medical procedures for all practice sessions and competitive events.
4. Supervises athletic coaches' enforcement of training rules and establishes uniform standards of appropriate conduct for the athletes in their charge.
5. Ensures all students who participate in sports are on the proper insurance lists, and that absolutely no student takes part in any practice without being properly insured.
6. Oversees the implementation of heat acclimation procedures.
7. Oversees the implementation of concussion and head injuries including return to play.
8. Arranges for the transportation for athletic competitions and when necessary coordinates with the high school principal to request approval for the early dismissal of student athletes.
9. Supervise all ticket sales and fundraising events of the athletic program and assumes responsibility for proper handling of funds.
10. Arranges field and gym practice schedules.
11. Enforces school rules of conduct for athletes and sportsmanlike spectator participation at games, and also infuses the student body with the elements of good sportsmanship and conduct.
12. Establishes a system of immediately reporting athletic injuries to the nurse.
13. Supervises the care, maintenance and storage of all athletic equipment and supplies and maintains a current inventory.
14. Promotes good school-community relations and support through effective communication regarding the district's athletic program.
15. Upholds and enforces school rules, administrative regulations and board policy.
16. In cooperation with Director of Facilities, coordinates the processing of requests for athletic facilities usage by all groups.
17. Performs other duties which may be within the scope of his/her employment and certification as may be assigned.

Personnel

18. Provides leadership in the selection, assignment and evaluation of athletic coaches and trainers.
19. Recruits, evaluates and recommends to the principal candidates for coaching positions.
20. Serves as a mentor for all members of the coaching staff to ensure the professional growth and development of all coaches.
21. Conducts at least one written evaluation of each coaching staff member per season to include observations of a team practice session and an interscholastic contest per coach.
22. Prepares an annual summary evaluation of every member of the coaching staff. Evaluations shall include recommendations for improvement as well as commendations, and shall provide the basis for the athletic director's employment recommendation of the individual coach.
23. Supervises cheerleading squad selection and activities.

<b>GENERAL DESCRIPTION:</b>						
<p>To assist the classroom teacher by working with individual and small groups of students with special needs to provide them with the academic, physical and emotional support as needed to gain optimum benefit from the district's special education program.</p>						
<b>RESPONSIBILITIES MAY INCLUDE, BUT ARE NOT LIMITED TO:</b>						
<ol style="list-style-type: none"> <li>1. Assists with individualized supplemental instruction and works with small groups of students under the supervision of the special education teacher to reinforce material initially introduced by the teacher. Checks notebooks and supervises testing and make-up work as assigned by the teacher. Assists the teacher in implementing the pupils' goals as set by the IEP. Serves as a resource person, if and when requested, to the Child Study Team conferring about one of the students to whom assigned. Assists regular education teachers and special education teachers in devising special learning strategies and/or behavioral modifications based on understanding of individual students, their needs, interests and abilities. Assists the teacher in implementing behavioral management systems. Serves as a source of information and help to any substitute teacher assigned in the absence of the regular teacher. Implements changes to a pupil's program only in consultation with the classroom teacher, child study team, related services staff or administration.</li> <li>2. Alerts the teacher to special needs of individual children.</li> <li>3. Assists, where appropriate, in escorting children to arrival/departure areas, loading and unloading of children with special needs from transportation buses or vans.</li> <li>4. Completes clerical duties as assigned by the special education classroom teacher or child study team member, including collecting behavioral data. Helps maintain individual records for each child. Refers parent requests for information to the classroom teacher.</li> <li>5. Assists teacher in the planning of the weekly schedule of activities and provides input in terms of student progress.</li> <li>6. Assists students with various projects, crafts, simple tasks such as sharpening pencils or carrying lunch trays, and curriculum tasks. Guides independent study, enrichment work and remedial work set up and assigned by the teacher. Helps students to master equipment or instructional materials assigned by the teacher.</li> <li>7. Assists with the supervision of children during emergency drills, assemblies, field trips, play and work experiences. Assists in escorting children from one area to another. 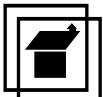
**1550 EQUAL EMPLOYMENT/ANTI-DISCRIMINATION AFFIRMATIVE

The Board of Education shall, in accordance with State statutes and administrative code and Federal law and regulations, strive to overcome the effects of any previous patterns of discrimination in **school** district employment practices and shall systematically monitor **school** district procedures to ensure continuing compliance with anti-discrimination laws and regulations.

The Board will ensure all persons regardless of race, creed, color, national origin, ancestry, age, marital status, affectional or sexual orientation, gender, gender identity or expression, religion, disability, or socioeconomic status shall have equal and bias-free access to all categories of employment in the public educational system of New Jersey, pursuant to N.J.A.C. 6A:7-1.1.

The Board will not enter into any contract with a person, agency, or organization that discriminates on the basis of race, creed, color, national origin, ancestry, age, marital status, affectional or sexual orientation, gender, gender identity or expression, religion, disability, or socioeconomic status, either in employment practices or in the provision of benefits or services to students or employees. **In addition, the Board will encourage minority businesses, women's business enterprises, and labor surplus area firms to submit bids to be considered for the awarding of contracts.**

The Board shall not assign, transfer, promote or retain staff, or fail to assign, transfer, promote or retain staff, on the sole basis of race, creed, color, national origin, ancestry, age, marital status, affectional or sexual orientation, gender, gender identity or expression, religion, disability, or socioeconomic status.

A. Purpose and Application

1. The purpose of this procedure is to give any **school** district employee or candidate for **school** district employment the opportunity to appeal an alleged violation of the **school** district's Affirmative Action Program for employment and contract practices, as set forth in Policy №. 1550 or in a plan formally adopted by the Board of Education and approved by the Commissioner.
2. No qualified handicapped person, shall, on the basis of handicap, be subjected to discrimination in employment and the Board will take positive steps to employ and advance in employment qualified handicapped persons in programs and activities.
3. This procedure is intended to facilitate an equitable and just resolution of a dispute at the most immediate level and should be implemented in an informal manner.
4. Every reasonable effort will be made to expedite the process in the interest of a prompt resolution. Time limits may, however, be extended with the consent of all parties.
5. All participants in the procedure will respect the confidentiality that this **school** district accords to information about individual staff members.

B. Definitions

1. "Board of Education" means the Board of Education of the Randolph School District.
2. "Complaint" means an alleged violation of the **school** district's Affirmative Action Plan or Policy.

3. “Complainant” means a staff member who alleges a violation of the **school** district’s Affirmative Action Plan or Policy №. 1550.
4. “Day” means a **business day working** or calendar day as identified.
5. “School district” **or “district”** means the Randolph School District.
6. “Violation” means the failure of a **school** district official or employee to take the positive steps outlined in Policy №. 1550 or the duly approved Affirmative Action Plan to remove impermissible bias or preference from all aspects of **school** district employment or contract practices and/or to correct the results of past discrimination.

### C. Procedure

1. A Complainant who believes that he/she has been harmed or adversely affected by a failure to enforce the **school** district’s Affirmative Action Plan for employment and contract practices shall discuss the matter with his/her immediate supervisor in an attempt to resolve the matter informally.
  - a. In the event the Complainant believes their immediate supervisor may be conflicted or if the immediate supervisor is not available, the Complainant may proceed directly to the school district’s Affirmative Action Officer as outlined in C.2. below.
  - b. In the event the Complainant believes the school district’s Affirmative Action Officer may be conflicted, the Complainant may submit a written complaint to the Superintendent of Schools who will designate a supervisor or administrative staff member to conduct the investigation in accordance with the procedures outlined in this Regulation. The Superintendent will ensure the supervisor or administrative staff member is provided affirmative action training in accordance with State mandates and guidelines.

2. If the matter is not resolved to the satisfaction of the Ceomplainant within ~~ten business thirty working days~~, the Ceomplainant may submit a written complaint to the Affirmative Action Officer. The complaint will include:
  - a. The Ceomplainant's name and address;;
  - b. The specific failure to act that the Ceomplainant complains of;;
  - c. The school officer or employee, if any, responsible for the alleged violation of the Affirmative Action Plan;;
  - d. The results of discussions conducted in accordance with paragraph C.1.-; and
  - e. The reasons why those results are not satisfactory.
3. The Affirmative Action Officer will investigate the matter informally and will respond to the complaint in writing no later than seven **business working** days after receipt of the written complaint. A copy of the complaint and the response will be forwarded to the Superintendent.
4. The response of the Affirmative Action Officer may be appealed to the Superintendent in writing within three **business working** days after it has been received by the Ceomplainant. The appeal will include the original complaint, the response to the complaint, and the Ceomplainant's reason for rejecting the response. A copy of the appeal must be given to the staff member alleged to have violated the Affirmative Action Plan.
5. ~~On his/her timely request (that is, submitted before the expiration of the time within which the Superintendent must render a decision), Upon request,~~ the Ceomplainant will be given an informal hearing before the Superintendent, at a time and place convenient to the parties, but no later than seven **business working** days after the request for a hearing has been submitted. The Superintendent may also require the presence at the hearing of the staff member charged with violation of the Affirmative Action Plan and any other person with knowledge of the violation complained of.

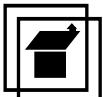

6. The Superintendent will render a written decision in the matter no later than seven **business working** days after the appeal was filed or the hearing was held, whichever occurred later. Copies of the decision will be given to all parties ~~and to the Board of Education.~~
7. The Ceomplainant may appeal the Superintendent's decision to the Board by filing a written appeal with the Board Secretary no later than three **business working** days after receipt of the Superintendent's decision. The appeal will include:
  - a. The original complaint;;
  - b. The response to the complaint;;
  - c. The Superintendent's decision;;
  - d. A transcript of the hearing, if one has been made, or a summary of the hearing to which all parties have consented; and
  - e. The Ceomplainant's reason for believing the Superintendent's decision should be changed.
8. A copy of the appeal to the Board must be given to the staff member, if any, charged with a violation of the Affirmative Action Plan.

### 8462 REPORTING POTENTIALLY MISSING OR ABUSED CHILDREN

The Board of Education recognizes early detection of missing, abused, or neglected children is important in protecting the health, safety, and welfare of all children. In recognition of the importance of early detection of missing, abused, or neglected children, the Board of Education adopts this Policy pursuant to the requirements of N.J.S.A. 18A:36-24 and 18A:36-25. The Board provides this Policy for its employees, volunteers, or interns ~~to provide~~ for the early detection of missing, abused, or neglected children through notification of, reporting to, and cooperation with the appropriate law enforcement and child welfare authorities pursuant to N.J.S.A. 18A:36-24 and 18A:36-25 et seq., N.J.A.C. 6A:16-11.1, and N.J.S.A. 9:6-8.10.

Employees, volunteers, or interns working in the school district shall immediately notify designated child welfare authorities of incidents of alleged missing, abused, and/or neglected children. Reports of incidents of alleged missing, abused, or neglected children shall be reported to the New Jersey State Central Registry (SCR) at 1-877 NJ ABUSE or to any other telephone number designated by the appropriate child welfare authorities.. If the child is in immediate danger a call shall be placed to 911 as well as to the SCR.

The person having reason to believe that a child may be missing or may have been abused or neglected may inform the Principal or other designated school official(s) prior to notifying designated child welfare authorities if the action will not delay immediate notification. The person notifying designated child welfare authorities shall inform the Principal or other designated school official(s) of the notification, if such had not occurred prior to the notification. Notice to the Principal or other designated school official(s) need not be given when the person believes that such notice would likely endanger the reporter or student involved or when the person believes that such disclosure would likely result in retaliation against the student or in discrimination against the reporter with respect to his or her employment.

The Principal or other designated school official(s) upon being notified by a person having reason to believe that a child may be missing or may have been abused or neglected, must notify appropriate law enforcement authorities. Notification to appropriate law enforcement authorities shall be made for all reports by employees, volunteers, or interns working in the school district. Confirmation by another person is not required for a school district employee, volunteer, or intern to report the suspected missing, abused, or neglected child situation.

School district officials will cooperate with designated child welfare and law enforcement authorities in all investigations of potentially missing, abused, or neglected children in accordance with the provisions of N.J.A.C. 6A:16-11.1(a)5.

The Superintendent will serve as the school district's liaison to designated child welfare authorities to act as the primary contact person between the school district and child welfare authorities with regard to general information sharing and the development of mutual training and other cooperative efforts. The Superintendent or designee will serve as the school district's liaison to law enforcement authorities to act as the primary contact person between the school district and law enforcement authorities, pursuant to N.J.A.C. 6A:16-6.2(b)1, consistent with the Memorandum of Understanding, pursuant to N.J.A.C. 6A:16-6.2(b)13.

An employee, volunteer, or intern working in the school district who has been named as a suspect in a notification to child welfare and law enforcement authorities regarding a missing, abused, or neglected child situation shall be entitled to due process rights, including those rights defined in N.J.A.C. 6A:16-11.1(a)9.

The Superintendent or designee shall provide training to school district employees, volunteers, or interns on the district's policy and procedures for reporting allegations of missing, abused, or neglected child situations. All new school district employees, volunteers, or interns working in the district shall receive the required information and training as part of their orientation.

There shall be no reprisal or retaliation against any person who, in good faith, reports or causes a report to be made of a potentially missing, abused, or neglected child situation pursuant to N.J.S.A. 9:6-8.13.

~~Any employee, volunteer, or intern with reasonable cause to suspect or believe that a student has attempted or completed suicide shall report the information to the Department of Human Services, Division of Mental Health and Addiction Services in a form and manner prescribed by the Division of Mental Health and Addiction Services pursuant to N.J.S.A. 30:9A-24.a.~~
