Referendum Project Review/Update

- a. Corridor Student Lockers to be installed 1st or 2nd week of Aug.
- b. Girls Locker Rooms revised bid will be opened on Tue. Rebids removed the AC from the RFPs to reduce cost.
- c. Turf Fields DeSilva dirt mounds established in prep for drainage installation. Mr. Neves will find locations to remove the mound of excess dirt. Both Desilva and Baur will have all 5 sports lined. Color for turf is expected to be green with alternating shades ever other 5 yards. Some discussion about changing color to blue. End zones will have lettering installed ie: RANDOLPH or RAMS and mid field to have "R" or rams mascot. Getting cost of adding mascot. Need a standard for the letting and the mascot. Discussed possibility of adding seating at DeSilvia, Neves to investigate.
- d. Baur field bleachers removed and progressing to new installs.
- e. Auditorium bid package expected to be sent out by next Spring 2013 for construction start summer of 2013.

Solar Update

- a. RHS: Received second conceptual design for 197.97 kW for roof top and 385.99 kW for car port in student parking lot. Permits issued 6/11. Soil conservation approval 6/19. Wanzek receiving bids on electrical subs on 6/20; pre-con meeting held 6/26; mobilization to start week of 7/9. Electrical contractor selected on 7/6.
- b. RMS: Received approval for 86.13 kW roof top system along with ballasted ground mount of 137.17 kW; permits issued 6/8; Soil conservation permit issued 6/19; Wanzek receiving bids on electrical subs on 6/20; pre-con meeting held 6/26; mobilization week of 7/9. Electrical contractor selected on 7/6
- a. Ironia School: Tree removal approved in courtyard to utilize roof top areas with shade loss; permits issued 6/8; Wanzek receiving bids on

electrical subs on 6/20; pre-con meeting held 6/26; mobilization week of 7/9 Electrical contractor selected on 7/6 Additional trees are being removed, submitting tree removal permit 7/6

a. Move in was accomplished. Old building is empty. Final negotiation with owner on-going regarding a small structure. Grand opening expected to be scheduled in September with the twp leading.
